A Surrogate Parent is an individual who is appointed by the school district of residence or a court to represent a student with a disability (1) whose parent cannot be identified or located, (2) who is a ward of the state, or (3) who is an unaccompanied homeless youth. Surrogate Parents assist in all matters relating to the identification, evaluation, and educational placement of the child and the provision of FAPE. Individuals must complete a 5-hour training and be approved by the district to serve in this capacity.

IEP Clinic:

Parents bring their child's IEP for an OCECD representative to review. Pre-registration appointments are scheduled to ensure sufficient time to review and discuss questions and concerns parents may have about their child's IEP. Break out sessions:

- (1) Understanding the IEP Process: Participants will gain an understanding of the IEP content and the documentation necessary to develop an IEP. Each section of the IEP will be reviewed with an explanation of what information is required and what may be recorded in the various IEP sections.
- (2) Reducing Barriers Through Advocacy Tips for Parents: Parents will learn practical strategies that will enable them to become confident advocates for their child's special education needs. The parent's role before, during, and after the IEP meeting will be explored. Suggestions for effectively communicating with school district personnel will be discussed.
