#### Superintendent's Weekly Wrap-up: Jan. 17-24, 2014

**House Bill (HB) 193 would delay new graduation test** – On Wednesday the Ohio House passed HB 193 that would delay the new graduation tests for one year. The new graduation tests are set to begin in the 2014-2015 school year. However, HB 193 would move the starting school year to the 2015-2016 school year. Specifically, students in the class of 2019, entering ninth grade after July 1, 2015, would be the first to take new college and work-ready tests instead of the current graduation test.

The bill also would provide a range of testing options, including a career-technical option, for students to graduate, and reduce the number of required end-of-course exams from 10 to five. The bill, which passed the House 99-1 now goes to the Senate. A full version of HB 193 can be viewed <u>here</u>.

**Senate Education Committee deliberates modification of zero-tolerance policies -**The Senate Education Committee met last week and heard testimony on Senate Bill (SB) 167. SB 167 is legislation that would modify zero-tolerance policies and would require a school board to adopt a policy that allows many factors to be considered prior to the suspension or expulsion of a student. Sen. Charleta Tavares (D-Bexley) offered sponsored testimony, saying the intent of the bill is to provide support for students who have behavior problems and ensure those students get the help they may need in school.

**The Ohio House of Representatives passes bill that would award credit to students for religious instruction** - The Ohio House passed House Bill (HB) 171 last week, which would give schools the option of awarding credit to students for religious instruction received during released time from school. The bill specifies that a student may only be released from school for religious instruction as long as the student's parent or guardian has given written consent and the course is off school property. In addition, the private entity conducting the course must maintain attendance records that are provided to the school, provide transportation when needed and assume liability for the student when excused from school for the purpose of religious instruction. The bill now goes to the Senate.

New Way to Determine Kindergarten Readiness Coming Fall 2014 - Teachers will have from the first day of school until November 1, 2014, to complete the readiness assessment. The language and literacy portion of the kindergarten readiness assessment may be used to meet the reading diagnostic assessment requirement of the Third Grade Reading Guarantee for kindergarten if the language and literacy items are administered by September 30. **District Operating Announcements Can Be Found In Many Places -** We make every effort to communicate accurate and timely notification of school closing, delays and other important announcements through the use of our district's automated call system, district website, Facebook Page, Twitter Account, and by contacting local TV and Radio Stations.

This year, WBNS-10TV has included a special "ticker" of information that only includes school districts in Franklin County and closely connected communities so families in the Columbus area don't have to wait for all of the districts to scroll by before seeing Hamilton Local's information (We are listed after Hilliard for some unknown reason). So we recommend you view WBNS-10TV to see our information more quickly than the other local TV channels.

Mr. Payne has reached out multiple times to NBC 4 to be included on their special Columbus-area ticker since we are the only district not listed as it skips from "Groveport" to "Hilliard". They have yet to include Hamilton Local with those other school districts. ABC 6 / FOX 28 only does this special ticker for the very large Columbus area school districts. Not all districts are represented in their abbreviated ticker.

We also contact 14 local radio stations with our information as well. Some of the stations that receive our info are: WTVN - 610AM, WCOL - 92.3 FM, WSNY - 94.7 FM, and WNCI - 97.9 FM.

**FASFA Pin Day** - As part of our HS Postsecondary Action Planning to: *Help more students pursue postsecondary education through local college access programs, financial aid advising, scholarship and grant availability advising, career guidance, and other services,* HS Counselors coordinated Pin Day, a day to allow all upperclassmen the opportunity to register for their FASFA Pin during their regular scheduled lunch period. The Free Application for Federal Student Aid (FAFSA) is the form used by the U.S. Department of Education to determine your Expected Family Contribution (EFC) by conducting a "need analysis" based on financial information, such as income, assets and other household information, which you (and your parents if you are a <u>dependent student</u>) will be asked to provide. The form is submitted to, and processed by, a federal processor contracted by the U.S. Department of Education (ED), and the results are electronically transmitted to the <u>financial aid</u> offices of the schools that you list on your application.

FAFSA is the application used by nearly all colleges and universities to determine eligibility for federal, state, and college-sponsored financial aid, including grants, educational loans, and work-study programs.

**Amendment to Whose IDEA Is This?** - As a result of the change to prior written notice (PWN) requirements stating that the IEP can no longer serve as Prior Written Notice, an amendment was needed to Whose IDEA Is This? The Memorandum to Amend Whose IDEA Is This? must now be distributed anytime Whose IDEA Is This? is provided to parents until notice of a revised parent procedural safeguards notice is made available for dissemination. This amendment is posted on the district website and can be <u>accessed</u> through this link.

A guidance document for the requirements of providing a copy of Whose IDEA Is This? and the amendment is also posted and can be <u>accessed through the this link</u>.

Effective immediately, the district must provide a Prior Written Notice (PWN) with every IEP. Any questions about this new requirement can be directed to the Office of Special Education.
