House Education Chair seeks to implement a two-year phase-in for switching high school science exams from physical science to biology - House Education Committee Chairman Gerald Stebelton (R-Lancaster) outlined the idea to implement a two-year phase-in for switching high school science exams required for graduation from physical science to biology and Senate Education Committee Chairwoman Peggy Lehner (R-Kettering) voiced support for it as they look to revisit problematic sections of the mid-biennium review. The statements came at the first meeting of the Chartered Nonpublic Graduation Requirement Committee, the body created in the mid-biennium review to hash out a compromise on what mandates the state can impose on graduation requirements for private schools.

Licensure system adds enhancements - On Friday, Oct. 31, the Ohio Department of Education unveiled a number of changes aimed at improving efficiency and the user's experience with online licensure applications. With these changes, the department is:

- Stopping the printing and mailing paper licenses, certificates and permits for applicants requesting these credentials.
- Allowing educators who are ready to request renewal of their credentials for 2015 the ability to do so beginning November 1.
- Unveiling changes to help users find appropriate license options.

On the department's website, the <u>main licensure Web page</u> and the <u>Apply for a New License page</u> include information in these same categories, with links to information about various licenses.

Huffman Looks to Gather Floor Votes after Panel OKs Common Core Repeal - The House Rules and Reference Committee quickly approved a bill to repeal the Common Core education standards with little fanfare and no discussion Wednesday, reporting it along party lines.

While Wednesday's hearing on HB597 was over within minutes of starting, it follows several hearings that featured hours of testimony for and against the measure, which would temporarily swap out Ohio's Common Core-aligned standards in favor of Massachusetts' pre-Common Core standards while state officials write new standards.

The meeting saw votes in favor of passage from Rep. Matt Huffman (R-Lima), the committee chairman, as well as Speaker William Batchelder (R-Medina) and Reps. Jim Buchy (R-Greenville), Tony Burkley (R-Payne), Tim Derickson (R-Oxford), Dorothy Pelanda (R-Marietta) and Andy Thompson (R-Marietta), who joined Huffman to sponsor the bill. Reps. Tracy Heard (D-Columbus) and Debbie Philips (D-Albany), the first- and second-ranking House Democrats, voted against the bill. Reps. Dan Ramos (D-Lorain) and Michael Ashford (D-Toledo) weren't at the hearing.

Huffman said after the hearing that he and other Common Core critics will now go in search of the 50 votes the bill needs to pass the chamber, saying the bill won't go to the floor absent that level of commitment.

While Rep. Gerald Stebelton (R-Lancaster), the House Education Committee chairman and a Common Core supporter, recently claimed a majority of the GOP caucus and the overall House opposes HB597 (see The Hannah Report, 10/21/14), Huffman said members' minds can change.

As an example, Huffman pointed to anti-sweepstakes measure HB7, which started out with middling support and even went to the floor without a firm commitment of 50 votes, only to become law when lawmakers came to realize the scope of the problem it was addressing. He said a similar wave of support is building as members learn more about the Common Core and the process by which it was developed.

Following the vote, the group Ohioans Against Common Core issued a statement urging Senate President Keith Faber (R-Celina) to take quick action to advance the bill through an "objective committee" -- a call to bypass Senate Education Committee Chairwoman Sen. Peggy Lehner (R-Kettering), who opposes HB597.

Heidi Huber, leader of the group, noted recent efforts to flood Gov. John Kasich's office with calls to stop Common Core. "We encourage all Ohio legislators, who were bypassed in the adoption of Common Core, to support HB597 toward that end," she said in a statement.

Meanwhile, school leadership groups and others expressed dismay over the vote.

In a joint statement, the Ohio School Boards Association (OSBA), Buckeye Association of School Administrators (BASA) and Ohio Association of School Business Officials (OASBO) urged members to reject the legislation if it comes to a floor vote.

"The committee's passing of HB597 is particularly troubling in light of the many school leaders from across the state who testified in favor of 'staying the course' with the Common Core State Standards. While more rigorous and challenging than the old standards, educators from Ohio's public schools have sent a clear message that these new standards are good for students," said BASA's Tom Ash.

Philanthropy Ohio and StudentsFirst Ohio also released statements critical of the bill vote.

"In addition to the time invested in helping prepare our students for success, much [has] been spent by foundations to support Ohio's new learning standards that could be lost as a result of HB597. We cannot afford to lose these investments," said Philanthropy Ohio President Suzanne Allen.

"Like most states, Ohio saw the need to set higher learning goals for students so they would be ready to compete internationally in the workforce. Given the consensus of everyone from the nation's governors to teachers to major employers, it is unfortunate that Ohio persists in a debate that should have long been settled," said Greg Harris, state director of StudentsFirst Ohio.

Ohio Federation of Teachers President Melissa Cropper likewise criticized the vote, saying the committee is "following politically charged rhetoric" when it

should be focused on other issues, like properly implementing the current standards and evaluating Ohio's overall testing requirements.

Occupational Therapists Do Much More than Handwriting - Our Occupational Therapist, Julia Lawson, has created a wonderful sensory room at our Elementary Building. We often have children who become over stimulated, overwhelmed, and frustrated with everyday school demands. We have children identified with Autism, sensory motor issues, oppositional defiant disorder, and a never-ending assortment of other diagnoses. Sometimes, children just need a place to calm down. Now, thanks to Julia Lawson, Hamilton Elementary has a place where that can happen.

PARCC Assessments and Special Education - Many teachers and parents have expressed concerns about the new generation of state-wide assessments and how that affects our special education students. There are two primary changes to which all parents should become aware:

We are no longer allowed to read the questions and answers for any area
of the English Language Arts assessments. As a result, our teachers are
no longer doing this for district short cycle assessments. The PARCC
requires that we read ALL of the English Language Arts assessments or
NONE of them. For now, we are keeping the bar high at Hamilton and

- continuing to work with the highest percentage of our students to advance their reading ability and not read the English Language Arts assessments except to a very few students. These decisions are made by the IEP team.
- No students even students on IEPs are allowed to use a calculator for the math calculation parts of the math PARCC. This is new. In the past, with the OAA, some students in grades 6 and above could be given a calculator as an accommodation. This is no longer allowed for the calculation parts of the PARCC.

Questions regarding these new assessments can be directed to your child's intervention specialist or Wynona Smith, Director of Special Education. We are all still getting new information every day from the Ohio Department of Education, so stay tuned. Sometimes, the IEP cannot keep up with the changes.
