STRS Ohio Launches Updated Member Website - On Sept. 6, STRS Ohio launched its updated, responsive member website to improve members' access to information about their pension system on multiple devices. The new site was a long-term project, done completely in-house as a collaboration between the Communication Services, Information Technology Services and Member Benefits departments. The updated site will now "detect" how members are connecting to it and display content appropriately on their smart phone, tablet or desktop computer. The site also was restructured to guide members to information related to the two key phases of their STRS Ohio membership — "During Your Career" and "Receiving Benefits."

Annual STRS Statement Testing Completed for Benefit Projections - With the passage of pension reform, projections of various retirement scenarios based on age and service will once again appear on members' Annual Statements. These projections will help members understand the personal impact of the pension changes.

In particular, members will be better able to understand the transition benefit, which is designed to ensure that members who retire after July 1, 2015, under the new 2.2% benefit formula, will receive the same or higher benefit than if they retired July 1, 2015, or earlier under the current formula. All members who are eligible for a July 1, 2015, as well as a July 1, 2016, retirement will be presented with both estimated benefits. If the transition benefit is the higher benefit, the member will see a July 1, 2016, benefit that is the same as the July 1, 2015 benefit.

Students in independent public schools do not have a athletic participation opportunity at Hamilton even if Hamilton is the parents' residential district - The Ohio High School Athletic Association (OHSAA) distributed and published on July 23, 2013, regarding the Budget Bill and the provisions contained therein, which affects participation opportunities for students, not enrolled in a district and/or attending Hamilton Local Schools.

Are students who attend the Ohio Virtual Academy, Ohio Connections Academy, ECOT, TRECA Digital Academy, etc. affected by the provisions of this Budget Bill?

Answer - No. The schools such as those mentioned above, along with all other community schools (defined as independent public schools that are part of the state's educational system created pursuant to ORC Section 3314.01), are not included in this legislation. Thus, unless the community school (sometimes referred to as a "charter school") is sponsored by a member school's Board of Education, students who attend "independent public schools" are not affected by these changes in the law and do not have a participation opportunity at the member public school in the parents' residential district. Please see Exception 3 of Bylaw 4-3-1 and the guidance here: http://ohsaa.org/eligibility/4-3-1.pdf for more information on this option for students who attend the Hamilton Alternative Academy which is sponsored by the Hamilton Local Board of Education. Keeping up with transportation rule changes - All student transportation in Ohio must comply with Ohio Revised Code (RC) and Ohio Administrative Code (OAC). On July 25, changes were enacted in eight of the administrative rules. There also were some changes in revised code enacted through the biennial budget bill, House Bill (HB) 59. Superintendent Lester has provided these updated rules to Assistant Superintendent Morrison and Transportation Coordinator Haughn. They will be updating the District's transportation operation and safety rules reference library.

Here is a summary review of the changes enacted.

OAC 3301-83-09 Pupil instruction.

Adds the requirement to train students in the dangers of trespassing on railroad rightof-ways and other dangerous areas. Eliminates the requirement to provide training in the first two weeks of school to students who do not ride on regular routes. (These students receive that training as part of a requirement to provide training for all passengers participating in non-routine trips at the time the trip is taken.)

OAC 3301-83-10 Personnel training program

- · Adds the requirement for a bus driver to meet the requirements of OAC 3301-83-06, in addition to the requirements in OAC 3301-83-10, before a pre-service certificate will be issued.
- Adds a requirement to train drivers in emergency evacuation procedures.
- · Requires drivers to meet all requirements of OAC 3301-83-06, including having a pre-service certificate and valid commercial driver's license, and then observe a route with an experienced driver and students aboard, and drive a route with an experienced driver and students aboard.
- · Adds a requirement to include bullying behaviors in training on student management.
- · Restricts the use of temporary pre-service certificates by individuals attempting to certify for the first time, or drivers whose pre-service certificate has not expired within the last 12 months.
- · Adds a time limit of 12 months for completing and reporting of all requirements for certification or recertification.
- · Adds a requirement for on-the-bus instructors to attend in-service trainings scheduled by pre-service instructors.

OAC 3301-83-16 Non-routine use of school buses

- · All references to fees have been removed from this rule and adopted in a new rule (OAC 3301-83-24).
- All of the itemized approved non-routine uses of school buses listed in the previous rule have been deleted. Those uses have been replaced with language stating that uses may require the school bus owner to obtain approval of the vehicle and operator as a

commercial motor carrier pursuant to the Federal Motor Carrier Safety Administration (FMCSA) and Ohio Department of Transportation, in addition to other rules. This change will be the most problematic for schools when they determine what trips are appropriate. In general, FMCSA regulations apply to commerce. As long as schools avoid any operations that can be construed as commerce, they should be able to continue to operate under the same regulatory controls as in past years.

- · Out-of-state travel on school transportation vehicles has been expanded to 1,000 miles in accordance with changes adopted in RC 3327.15.OAC 3301-83-22 Vehicle maintenance.
- The Ohio State Highway Patrol must be notified within 15 days of any school buses involved in accidents that result in mechanical damage or damage in excess of \$1,000. The former rule set the value for damage at \$500.

OFFICE OF THE ASSISTANT SUPERINTENDENT

Civil Rights - Mr. Morrison is reviewing data to submit for the new Civil Rights Data Collection Survey. This collection of data regarding the access to educational opportunities for public school students is a yearly and on-going collection of information that allows policymakers and researchers to review and develop better ways to work with children.

Health and Safety - Ohio immunization law (ORC 3313.671) requires children to meet state immunization requirements for continued school attendance. The Ohio Department of Health has revised the School Immunization Requirements to include a dose of Td or Tdap to be administered before a student enters the seventh grade. Record of immunizations must be provided to our middle school or your child is subject to exclusion. Please contact Mrs. Kathy Brickey, School Nurse, immediately with questions or concerns.

Food Services - OCTOBER IS NATIONAL FARM TO SCHOOL MONTH, a time to celebrate the connections that are happening all over the country between schools and local food. In 2010, Congress approved a resolution to officially designate October as National Farm to School Month. The passage of House Resolution 1655 demonstrates the growing importance of farm to school programs as a means to improve child nutrition, support local economies and educate children about the origins of food.

Preparing Students for College - As part of our HS Postsecondary Action Planning to: Help more students pursue postsecondary education through local college access programs, financial aid advising, scholarship and grant availability advising, career guidance, and other services, On Wednesday, September 25, 2013, the PLAN test was administered to all 10th grade students and a practice ACT test was administered to all 11th grade students. The PLAN is a curriculum-based assessment program for 10th grade students designed to assess academic progress and provide an early indicator of college readiness. The PLAN will help students understand and explore the wide range of career options, as well as assist in enhancing a high school coursework plan that prepares them to achieve their post-high school goals. More information about the PLAN including sample test questions and guidance for interpreting PLAN scores is available at the PLAN website, www.planstudent.org.

The practice ACT test will give our 11th grade students the opportunity to familiarize themselves with ACT test questions, test-taking strategies, and conditions similar to the actual ACT testing environment. This opportunity will give the students feedback on how well they performed in the subject content areas of English, Mathematics, Reading and Science.
